4. General Assembly – Minutes 2011

The meeting reviewed the minutes of the 2011 General Assembly and suggested a number of minor amendments.

Re: JSTOR: The Toscaireacht noted that it had agreed at its meeting on 5 December 2011 that the level of interest among members would be ascertained before exploring the cost and IT steps involved in establishing access for members to JSTOR. It was agreed that the post out of papers to members in advance of the General Assembly 2012 would include a sheet inviting members to indicate their interest or not in JSTOR. Members would be asked to return the sheet to the Artists' Support team in the Arts Council or the registration desk at the General Assembly.
